What?	The types of personal information we collect and share depends on the product or service you have with us. This information can include: • Tax Identification Number, Date of Birth, Telephone Number and Address • Annual Income, Tax Bracket, Account Balances and Transaction History • Net Worth, Assets and Employment History
	When you are <i>no longer</i> our customer, we continue to share your

information as described in this notice.

How?	All financial companies need to share clients' personal information to run their everyday business. In the section below, we list the reasons companies can share their clients' personal information; the reasons Wealthspan Investment Management, LLC chooses to share; and whether you can limit this sharing.

Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit only</li> <li>Sharing for affiliates' everyday business purposes-information about your creditworthiness</li> <li>Affiliates from using your information to market to you</li> <li>Sharing for non-affiliates to market to you</li> <li>State laws and individual companies may give you additional rights to limit sharing.</li> </ul>

Definitions	
Affiliates	<ul><li>Companies related by common ownership or control. They can be financial and nonfinancial companies.</li><li>Wealthspan Investment Management, LLC does not share with affiliates so they can market to you.</li></ul>
Non-affiliates	<ul> <li>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>Wealthspan Investment Management, LLC does not share with non-affiliates so they can market to you.</li> </ul>
Joint Marketing	<ul> <li>A formal agreement between non-affiliated financial companies that together market financial products or services to you.</li> <li>Wealthspan Investment Management, LLC does not jointly market.</li> </ul>
